


Figure 1.1 Federal Government Spending as a % of GDP, 1930–2003 Gruber: Public Finance and Public Policy, First Edition Copyright © 2005 by Worth Publishers




Figure 1.2 Total Government Spending Across Developed Nations, 1960–2001 Gruber: Public Finance and Public Policy, First Edition Copyright © 2005 by Worth Publishers




Figure 1.3 Federal vs. State/Local Government Spending, 2003 Gruber: Public Finance and Public Policy, First Edition Copyright © 2005 by Worth Publishers




Figure 1.4 (a) Federal Revenues and Expenditures, Surplus or Deficit, and Debt, 1930–2003 Gruber: Public Finance and Public Policy, First Edition Copyright © 2005 by Worth Publishers




Figure 1.4 (b) Federal Revenues and Expenditures, Surplus or Deficit, and Debt, 1930–2003 Gruber: Public Finance and Public Policy, First Edition Copyright © 2005 by Worth Publishers




Figure 1.4 (c) Federal Revenues and Expenditures, Surplus or Deficit, and Debt, 1930–2003 Gruber: Public Finance and Public Policy, First Edition Copyright © 2005 by Worth Publishers




Figure 1.5 Debt Levels of OECD Nations in 2003 Gruber: Public Finance and Public Policy, First Edition Copyright © 2005 by Worth Publishers




Figure 1.6 State and Local Government Receipts, Expenditures, and Surplus, 1947–2003 Gruber: Public Finance and Public Policy, First Edition Copyright © 2005 by Worth Publishers

(a) Federal spending (% of total spending)




Figure 1.7 (a) The Distribution of Federal and State Expenditures, 1960 and 2001 Gruber: Public Finance and Public Policy, First Edition Copyright © 2005 by Worth Publishers

(b) State/local spending (% of total spending)




Figure 1.7 (b) The Distribution of Federal and State Expenditures, 1960 and 2001 Gruber: Public Finance and Public Policy, First Edition Copyright © 2005 by Worth Publishers

(a) Federal revenues (% of total revenue)




Figure 1.8 (a) The Distribution of Federal and State Revenues, 1960 and 2003 Gruber: Public Finance and Public Policy, First Edition Copyright © 2005 by Worth Publishers

(b) State/local revenues (% of total revenue)




Figure 1.8 (b) The Distribution of Federal and State Revenues, 1960 and 2003 Gruber: Public Finance and Public Policy, First Edition Copyright © 2005 by Worth Publishers
