The Financial Certification Form is used to determine your ability to meet the cost of attending MIT. The form is complete only when financial documentation (e.g. letters from banks certifying availability of funds, letters of sponsorship from governments or employers, copies of MIT award letter) is attached. According to US immigration regulations, MIT cannot issue Certificates of Eligibility – the I-20 and DS2019 forms – necessary to obtain F-1 or J-1 visas unless applicants have been offered admission to the Institute, and have submitted documented evidence of sufficient funds. If the necessary financial documentation is not on file in the International Students Office, additional correspondence will delay the issuance of the Certificate of Eligibility and the process of obtaining the visa.

Please complete this form and return it to the International Students Office even though you may have already submitted the financial documentation (documents certifying sufficient funds) with the initial application. Students who have received a research or teaching assistantship, which covers the estimated expenses should also complete this form, attach a copy of the award letter received from the department, and return them to the International Students Office. Please remember that if your assistantship is for the academic year only (9 months), you are required to document funding for the summer living expenses as well (12 months).

Estimated Expenses for Graduate Students for 2007-2008

The *estimated* expenses for twelve (12) months for a single (unmarried) graduate student are \$62,000. This includes tuition and fees, medical insurance and living expenses.

Students bringing dependents should add \$11,000 for a spouse and \$4,500 for each child.

The *estimated* expenses for twelve (12) months for a Sloan Master's Program student are \$76,000.
