Why a Strategic Plan?

- Parallels DSL strategic planning effort
- Revisits and updates previous strategic efforts
- Sets a new vision for next 5 years and beyond
- Refocuses community on common goals
- Outlines a systematic approach to facility issues



Role of the Champions

Role - the project manager for this initiative

- Define what success means a document, a program in place
- Create team if needed
- Do not expect you to do it but to get it done
- Define the pieces needed these are a list of tasks that when done will mean that the task is successfully accomplished

Define the tasks - We have used the Smart goals approach

- Define Specific tasks
- Ensure that tasks are Measureable
- Ensure that tasks are Achievable
- Ensure that tasks are Relevant
- Set the Time frame for accomplishing each task



Champions' Responsibilities

Responsibility

Complete responsibility for detail design and implementation of this piece of the Strategic Plan.

Not just the product but its implementation.

"At MIT if the process has not been done, it will just be another report".



Role of the Theme Steering Committees

- Technical experts / advisers for specific initiatives – put champions in touch with resources to accomplish their tasks
- Coordinate implementation plans and resources to execute tasks laid out by champions
- Identify synergies between initiatives to ensure overall progress of the theme
- Advisory group to champions and volunteers – sounding board for ideas

Panhel Strategic Plan Thoughts

The LGC's Involvement

- Passed a resolution on May 9 expressing support for the plan
- Provided input to keep the plan inclusive for the LGCs
- LGC Secretary serves on Executive Committee





Role of the Executive Committee

- Composed of AILG Vice Chair, IFC and Panhel VPs, LGC Secretary, and Theme Steering Committee Facilitators
- Responsible for strategic oversight of all plan activities



- Coordinates with 4 governing councils and MIT
- Advocates for and is the public voice for the plan
- Seeks funding for plan initiatives



Advisory Committee

- Composed of DSL and DUE representatives, Corporation member, AILG Ombuds, faculty member
- Acts as a Visiting Committee; provides 50,000 ft view
- Meets ~3 times per year with Executive Committee
