After 9:00 we focused on BSF inspections and how these should be done. Specifically it was discussed if two inspections per year per house might make sense.

The following comments came from this discussion:

A couple of Items before year's end:

- 1) I've attached the Safety Checklist I give to Houses prior to my pre-inspection.
- 2) I've attached a spreadsheet of my hours over the last 6+ years. The top section shows running totals. The middle section shows actual hours. The bottom is a graph of the running totals. 2015-2016 is skewed because it assumes I have no hours for the rest of the year.

A typical year (2013-2014 was the year from hell and I was reimbursed for the overtime)

shows a lot of work in the fall and the spring. I am contracted for 600 hours, an average of 50 hours/month. I think it is fair to say that normally I have a surplus of 130 or so hours by the end of the year.

My current contract pays \$40,000/year ( $\$40,000/600=\$66.67/\text{Hour}$ ).

Right now I do 28 pre-inspections reports in the Fall and 27 in the Spring. There are a total of 37 reportable buildings in the system. Doing everyone in the Fall and Spring would add  $37*2-(28+27)=19$  more inspection reports to my schedule. My records show they take around 4 hours to generate, so that's  $19*4=76$  extra hours or so.

In fact, the SLI spec already allows for an extra BSF inspection for everyone whose Fire Department and Inspectional Services inspections share the same pre-inspection date. From section 5.2:

"The inspection package includes four inspections between July 1st and June 30th for \$500. The four included inspections can be used for required or optional inspections."

So the only change would be whether the extra inspection is initiated by the House or by the BSF.
