## **5F/H COMPRESSOR ANNOUNCEMENT**

CARLYLE COMPRESSOR IS PLEASED TO ANNOUNCE A NUMBER OF IMPORTANT IMPROVEMENTS IN CARLYLE'S LINE OF 5F/H OPEN COMPRESSORS. THESE OPEN COMPRESSORS HAVE ALWAYS BEEN KNOWN FOR THEIR DURABILITY, RELIABILITY, AND HIGH PERFORMANCE. WE ARE NOW MAKING THEM EVEN MORE ATTRACTIVE TO USE BY IMPROVING THEIR WARRANTY AND OFFERING ADDITIONAL FACTORY INSTALLED ACCESSORIES.

### **o NEW 3 YEAR WARRANTY**

EFFECTIVE JULY 1, 1990 CARLYLE COMPRESSOR IS ANNOUNCING THAT NEW OEM 5F/H OPEN COMPRESSORS WILL NOW BE COVERED BY A 3 YEAR WARRANTY. THIS NEW POLICY WARRANTS 5F/H OEM COMPRESSORS SOLD BY CARLYLE TO BE FREE FROM DEFECTS IN MATERIAL AND WORKMANSHIP FOR A PERIOD OF 36 MONTHS FROM DATE OF INSTALLATION OR 48 MONTHS FROM DATE OF MANUFACTURE, WHICHEVER PERIOD FIRST EXPIRES. THIS NEW WARRANTY POLICY WILL COVER ALL 5F/H OPEN COMPRESSORS WITH SERIAL NUMBERS STARTING 0190J\_\_\_\_\_ (MANUFACTURED THE 1ST PRODUCTION WEEK OF 1990). FOR OLDER COMPRESSORS INSTALLED AFTER JULY 1, 1990, CARLYLE IS REQUESTING NOTIFICATION BY THE OEM OF THE INSTALLATION DATE AT THE TIME OF UNIT SHIPMENT. FINAL DETAILS OF THIS NEW WARRANTY POLICY ARE NOW BEING PREPARED AND WILL BE SENT TO YOU IN THE NEXT 30 DAYS.

AFTER RECEIVING REQUESTS FROM A NUMBER OF OEM CUSTOMERS, CARLYLE HAS NOW IMPLEMENTED A PROGRAM TO OFFER 5F/H COMPRESSORS ON FACTORY INSTALLED BASES AND A NUMBER OF FACTORY INSTALLED ACCESSORIES. THESE IMPROVEMENTS INCLUDE :

### **o 5F40 THRU 5H126 BASE MOUNTED COMPRESSORS FOR DIRECT DRIVE APPLICATIONS**

THESE NEW UNITS WILL HAVE OUR STANDARD 5F/H COMPRESSORS SUPPLIED ON A STURDY STEEL BASE. THE COMPRESSOR WILL NOW ALSO INCLUDE A DUAL HIGH/LOW PRESSURE SWITCH FACTORY INSTALLED ON THE COMPRESSOR. IN ADDITION, A COUPLING GUARD WILL BE ATTACHED TO THE BASE ASSEMBLY.

### LIMITED WARRANTY

Carlyle Compressor, Division of Carrier Corporation, ("Carlyle") warrants 5F/H open compressors manufactured and sold by Carlyle to be free from defects in material and workmanship for a period of 36 months from the date of original installation or 48 months from the date of manufacture, whichever period first expires.

**The Buyer or End User's exclusive remedy and Carlyle's liability under this warranty shall be limited, at Carlyle's option, to repair, replacement or credit as follows:** Repair of the defective compressor, part or component; or replacement of the same with a new or remanufactured compressor, part or component; or refund of the original purchase price; or issuance of a credit for the original purchase price, providing that the failed compressor or component is returned to Carlyle within 60 days from date of failure. After 60 days, Carlyle may, at its option, issue a reduced credit instead.

**THIS WARRANTY DOES NOT INCLUDE LABOR COSTS.** Labor, material and other expenses related to the removal, replacement, and transportation of defective compressor parts or components are the End User's responsibility.

**THIS EXPRESS WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, WHICH ARE HEREBY EXCLUDED.**

The warranty stated above is limited to the original End User of the compressor, parts or components: is limited to compressors installed in the United States or Canada; and covers only the basic compressor and the compressor components installed by Carrier/Carlyle. Customer installed compressor accessories (manufactured by Carrier or Carlyle) such as crankcase heaters, pressure switches, external unloaders, flywheels, couplings and mufflers, will have this same warranty but limited to 12 months from date of installations or 20 months from date of manufacture, whichever occurs first.

**CARLYLE SHALL NOT BE LIABLE FOR SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES OR LOSSES FROM ANY CAUSE WHATSOEVER, INCLUDING, WITHOUT LIMITATION, LOSS OF USE, COMMERCIAL PROFITS, OR CUSTOMER GOODWILL, AND ANY OTHER CLAIMS BASED ON CONTRACT OR TORT.**
