TO: Sony Intelligence Dynamics Laboratories, Inc.

In consideration of the allowance or benefits paid for my services in the course of my internship at Sony Intelligence Dynamics Laboratories, Inc. ("SIDL"), and the use of the facilities and experience at SIDL, I voluntarily agree as follows:

1. I understand and agree to disclose and assign to SIDL, promptly and fully, all inventions, ideas or other suggestions (whether or not patentable), all confidential information, all copyrightable works and all mask works, made or conceived by me (alone or jointly with others) during the period of my internship at SIDL which: (a) relate or correspond to the actual or anticipated business, research and development or investigations of SIDL which at the time of conception are within the scope of my internship, or which relate or correspond to any other actual or anticipated business, research and development or investigations of SIDL which I become aware of as a result of my internship at SIDL, knowledge of which I would not ordinarily have but for my internship at SIDL; or (b) result directly, or indirectly, from, or are suggested by, any work which I have done or may do for or on behalf of SIDL; or (c) are developed, tested, improved or investigated, either in part or entirely, on time for which I was paid by SIDL or while I was using or receiving the benefit of any resources of SIDL.

2. I further agree to execute at any time, during or after my internship, an assignment for each such invention, confidential information, copyright work or mask work as SIDL may request and on such forms as SIDL may provide. I will promptly and fully assist SIDL during and subsequent to my internship in every lawful way, including the signing of any and all lawful papers, taking all lawful oaths, and doing all lawful acts, including giving testimony, without reimbursement other than my normal compensation as an employee of SIDL, except for a reasonable payment for the time involved in the event my internship at SIDL has terminated, to obtain, secure and protect for the benefit of SIDL, at the expense of SIDL, all patents, copyrights, mask works or other proprietary rights for Inventions, copyright works or mask works in any and all countries, regardless of whether I personally believe such rights to be protectable under law.

3. I agree not to disclose any confidential information or proprietary information of SIDL (including, but not limited to: business plans, customer lists, drawings, computer programs (in any form), accounting methods, inventories, inventions, processes, technological innovations and identity of SIDL employees and their areas of expertise), including information received in confidence by SIDL from others, either during or after my internship at SIDL, except upon the prior written consent of SIDL. It is understood that such confidential information and proprietary information of SIDL includes matters that I conceive or develop as well as matters I learn from other employees of SIDL. I will not, except as SIDL may otherwise consent or direct in writing, reveal or disclose, sell, use, lecture upon, or publish any confidential information or proprietary information of SIDL, or authorize anyone else to do these things, at any time, either during or subsequent to my internship at SIDL. This clause shall continue in full force and effect and survive after the expiration of my internship period.

4. I agree that during the period of my internship at SIDL, I will not disclose to SIDL or use in the course of my internship at SIDL any trade secrets or other proprietary information which I may have acquired because of internship at an employer other than SIDL, whether such information is in my memory or embodied in a writing or other physical form.

5. I recognize that ideas, inventions, confidential information, copyright works or mask works relating to my activities while working for SIDL and conceived or made by me, alone or with others, within one year after the expiration of my internship period may have been conceived in significant part while employed by SIDL. Accordingly, I agree that such ideas, inventions, confidential information, copyright works or mask works shall be presumed to have been conceived during my internship at SIDL and are to be assigned to SIDL under the terms of this Agreement unless and until I have clearly established the contrary by appropriate documentation and support.

6. Should I breach any provision of this Agreement, I agree that I shall be responsible for any damage that SIDL may suffer as a result of such breach, and SIDL may at any time terminate my internship at SIDL.

7. This Agreement shall be deemed to have been made and executed in Japan and any disputes arising hereunder shall be resolved in accordance with the laws of Japan.
